1. INTRODUCTION

Approved by the IOC, wushu is officially included in the sport program of 4th Youth Olympics Games (YOG) in Dakar, Senegal in 2026. In an aim to fully prepare for the YOG wushu competition from technical aspect, to ensure the high-level of judging/scoring quality of wushu competition, with the support of the Chinese Wushu Association (CWA), the International Wushu Federation (IWUF) organizes this judges' training course by reinforcing the judges' comprehension and execution of judging methods of wushu taolu competition.

2.1 Date: April 10-16, 2025

2.2 Place: Jiangyin city, China

2.3 Training Place: Culture and Sports Indoor Stadium (5F), Jiangyin City, China.

3. COURSE CONTENT

- 3.1 Judging Training: Learn and master the scoring methods for the 3rd set of International Wushu Competition Routines Changquan, Gunshu, Taijiquan and Taijishan routines.
- 3.2 Technical Training: Learn and master the 3rd set of International Wushu Competition Routines Changquan, Gunshu, Taijiquan and Taijishan routines.

5. QUALIFICATIONS

5.1 Membership

- Only those member federations/associations which have paid their IWUF annual membership fees for 2024 will be permitted to participate in the course.
- The federation/association applying to join IWUF may be invited to take part in the





course after their applications have been accepted by the IWUF.

5.2 Quota

Each federation/ association may at most submit three (3) Taolu international grade judges to participate in the course.

5.3 Eligibility for Participants

- All participants must be submitted to the course by their respective IWUF Member Federations/Associations.
- All participants must be official citizens of the countries/territories submitting them and should carry their submitting countries/territories' passports.
- All participants must hold a valid license for the Taolu judges certificate by the IWUF in 2023 and 2024.
- All participants should be in good physical health.

6. ENTRIES

6.1 Final Entry

- All final entries must be submitted through the IWUF Online Registration System.
- All sections of the online entry must be completed in full, including the uploading of the various required documents.
- All participants must input their valid IWUF judges license numbers through the online registration system.
- Each participant is required to print a copy of the submitted entry and present it upon arrival and registration.
- The online registration will be opened on **January 15, 2024** and closed on **February 28, 2025**, 24:00 (Beijing Time).

6.2 Late Entry Policy

- The deadline for late registration and changes is due on **March 28, 2025**, 24:00 (Beijing Time).
- Late entries or information change (changes due to incorrect or missing registration information) are subject to the approval of the IWUF and, if accepted, are subject to a late-entry fee of US\$ 100 per person.
- The above fees must be paid via wire transfer to the IWUF Secretariat before **March 28, 2025**, 24:00 (Beijing Time).

9. ARRIVAL & REGISTRATION

10. FINANCIAL CONDITIONS

11. COSTUME REQUIREMENTS

- 11.1 All participants should wear flexible wushu clothes and shoes on the technical training days.
- 11.2 Participants who wear tight uniforms that are not suitable for training or shoes with hard or sharp edges may be refused to attend the training sessions.

12. PASSPORT & VISA REQUIREMENTS

- 12.1 All participants must hold a valid passport and should allow plenty of time for visa application and processing. To ensure as few complications during visa application and travel as possible, it is suggested that all participants' passports are valid for at least six months following their final day of travel.
- 12.2 Participants who require visa invitation letters should sent their requests to IWUF and Chinese Wushu Association via events@iwuf.org and wushu@wushu.com.cn before January 20, 2025.

13. RESPONSIBILITY OF MEMBER FEDERATIONS

National/Territorial Federations (NFs) are responsible for their participants adhering to the IWUF and to all relevant rules established by the IWUF and the Organizing Committee.
